◀Notes on the use of crypto-assets▶

○The price of crypto-assets may fluctuate. The price of crypto-assets may plummet and you may lose money.

○Crypto-asset exchange service providers need to be registered with Financial Services Agency and Local Financial Bureau. When using crypto-asset exchange service, please confirm whether it is a registered service provider or not on the websites of Financial Services Agency and Local Financial Bureau.

○When trading crypto-assets, be sure to receive explanations from the service provider you intend to use and fully understand the details and risks (price fluctuation risk, cyber security risk, etc.) of the transaction, including whether the service provider has received administrative punishment from Financial Services Agency and Local Finance Bureau.

○Consultations regarding crypto-assets and fraudulent coins are increasing. Please be aware of scams and malicious business practices that take advantage of the buzz of crypto assets or take advantage of the entry of crypto-assets exchange business.
