International Focus on Global Financial System

An exclusive group of leading corporate executives and financial securities regulators will gather in New York next week in order to discuss emerging international issues concerning the regulation of global securities markets.

The conference is taking place as the international corporate community having overcome recent difficulties, now enters a new more confident phase and a period where investors increasingly regain confidence in the operations of global financial markets.

The Chairman of the IOSCO Technical Committee, Andrew Sheng said that "It is important at this time that we look for ways to improve global capital markets and at the same time overcome problems facing corporations, financial firms, investors and regulators".

"We also view this as an opportunity to brainstorm at the very highest levels for solutions to issues that we do not yet face, but nonetheless see clearly looming on the horizon".

The conference will comprise a series of "roundtable discussions" on a wide variety of different topics ranging from the evolving role of stock exchanges to the rights of shareholders to the impact of new technology on securities business and regulation.

The keynote speech at the conference will be delivered by Mr. William H. Donaldson, Chairman of the US Securities Exchange Commission (SEC).
